Preamble

Over a period of time, the ecological balance and the modern approach has led to equity in the society, and to overcome this, the Government came with the Unnat Bharat Abhiyan to uplift the rural parts of the country. The main aim of UBA was to use eco-friendly technologies that could be easily accessed by the people of villages and help them lead a decent livelihood and provide them with shelter, food, and basic necessities. UBA is a highly challenging scheme as it allows the students and faculty of various Higher Educational Institutes to devise methods and technologies for the betterment of rural populations. Especially in the agricultural field, as 71% of India's rural population is involved in agrarian activities.

Unnat Bharat Abhiyan is a government program with a unique, transformative and comprehensive approach to development. It anticipates the development of chosen communities in a variety of sectors, including agriculture, health, education, cleanliness, and the environment, in an integrated manner. Unnat Bharat Abhiyan not just to promotes infrastructure, but also links people's involvement, women's equality, hygiene, social justice, educational establishments and localities among rural areas and their people, and other initiatives.

The rationale of linking the rural people with the latest available technologies from the research and development institutes is highlighted through the mission of UBA in the form of knowledge flow from College – Knowledge- Village. This paradigm shift of working in close collaboration with the college and village through the faculty and the young students of the college will help in sensitising the young brains for their responsibilities for the overall development of the rural people,.

History

The conceptualization of Unnat Bharat Abhiyan started with the initiative of a group of dedicated faculty members of Indian Institute of Technology (IIT) Delhi working for long in the area of rural development and appropriate technology. The concept was nurtured through wide consultation with the representatives of a number of technical institutions, Rural Technology Action Group (RuTAG) coordinators, voluntary organizations and government agencies, actively involved in rural development work, during a National workshop held at IIT Delhi in September, 2014. The workshop was sponsored by Council for Advancement of People's Action and Rural Technology (CAPART), Ministry of Rural Development, Govt. of India. The program was formally launched by the Ministry of Education (MoE) (formerly Ministry Human Resource Development (MHRD)) in presence of The President of India on 11th November, 2014 and later, Unnat Bharat Abhiyan 2.0 was launched on April 25, 2018.

Vision

Unnat Bharat Abhiyan (UBA) is inspired by the vision of transformational change in rural development processes by leveraging knowledge institutions to help build the architecture of an Inclusive India.

Mission

The Mission of Unnat Bharat Abhiyan is to enable higher educational institutions to work with the people of rural India in identifying development challenges and evolving appropriate solutions for accelerating sustainable growth. It also aims to create a virtuous cycle between society and an inclusive academic system by providing knowledge and practices for emerging professions and to upgrade the capabilities of both the public and the private sectors in responding to the development needs of rural India.

Goals

- To build an understanding of the development agenda within institutes of Higher Education and an institutional capacity and training relevant to national needs, especially those of rural India.
- To re-emphasize the need for field work, stake-holder interactions and design for societal objectives as the basis of higher education.
- To stress on rigorous reporting and useful outputs as central to developing new professions.
- To provide rural India and regional agencies with access to the professional resources of the institutes of higher education, especially those that have acquired academic excellence in the field of science, engineering and technology, and management.
- To improve development outcomes as a consequence of this research. To develop new professions and new processes to sustain and absorb the outcomes of research.
- To foster a new dialogue within the larger community on science, society and the environment and to develop a sense of dignity and collective destiny.

Registration of Viillages under Unnat Bharat Abhiyan in MAFSU

The five constituent Veterinary Colleges under MAFSU have adopted 25 villages under UBA in first phase. In the second stage the university has registered 5 villages for the remaining one Post Graduate veterinary College, two Diary technology colleges and two Fishery Science colleges.

The Director of Extension Education, MAFSU, Nagpur University has taken the lead to implement this flagship programme through the constituent college with the provision of financial support for the organization of various developmental region in these villages.

Accordingly as per the resolution No 104/2022 of the 89th Executive Council meeting held on 23rd of August, 2022 a budgetary provision of Rs. 50000/- (Rupees Fifty Thousand only) per village per year from the revenue receipt of the University upto 25-26 for the implementation of extension activities in the adopted villages under UBA was approved.

Implementation of rural development activities in adopted villages under UBA:

The following guidelines are formulated for the implementation of UBA in the University. The overall monitoring of the programme and distribution of grants will be through the Director, Extension Education, MAFSU, Nagpur.

Indicative List List of activities to be undertaken in the adopted village

- 1. Animal health Camps/ vaccination camps/infertility camps/surgical camps
- 2. On-farm Demonstrations
- 3. Farmers-scientist meets
- 4. Training Programs
- 5. Exhibitions / Livestock shows
- 6. Workshops
- 7. Kisan gosti
- 8. Farm -Field Visits
- 9. Awareness campaign
- 10. Celebration of National / International days
- 11. Cluster meeting with the villages / line departments
- 12. Cleanliness drives

Note: other activities deemed essential for the overall development of the villages may be organized as per the specific needs in the village

The above list is indicative only; other programmes for the overall development of the adopted villages may be planned in collaboration with the line departments like agriculture, horticulture, local self-governing bodies, revenue, banks, nearby colleges, etc.

The expenditure will be made on the POL, banners, medicines, demonstrations, farm and field visits, tours, remunerations (outside experts) and other contingent expenditures for the organization of the various events in the adopted villages.



Roles and duties of the staff involved in the UBA activities

1. Implementation authority at University Level: Dr. A. U. Bhikane

Director Extension Education MAFSU, Nagpur

- Guidance to coordinator in planning, controlling and coordinating activities in the constituent colleges in consultation with all regional coordinating institutes (RCI).
- ❖ To coordinate and monitor the various activities of UBA in the university and maintain liaison with all the RCIs.
- To finalize and approve guidelines for implementation of the UBA activities.
- Disbursement of grants to colleges.

2. University Coordinator UBA: Dr. Sariput P. Landge

Assistant Professor and Technical Officer Directorate of Extension Education MAFSU, Nagpur.

- > To register the university and all constituent colleges under UBA and maintain liaison with all the RCIs.
- ➤ Will assist DEE and Project Coordinator in the planning, coordinating and monitoring activities of the project.
- > To prepare the guidelines for implementation of the UBA activities.
- > Put-up the files to DEE for the disbursement of money to colleges..
- > To maintain up to date record of correspondence related to project.

3. Implementation authority at College Level: Associate Dean

- ✓ All the activities are to be organized under the guidance of the Associate Dean of the respective colleges.
- ✓ Appoint one academic staff member as UBA coordinator for the college with the responsibility of one village
- ✓ Appoint one academic staff as UBA Co-coordinator for each adopted village for the remaining four villages in case of five adopted villages.
- ✓ To approve the purchase and passing of all bills. •
- ✓ To forward the official correspondence to the University.



4. College Coordinators and co-cordinators for UBA

- ➤ To plan, coordinate and execute the various planned activities in coordination with other village level UBA Co-coordinators.
- > Conduct the household and village survey and uploading on UBA portal
- > Maintain the record of the village wise activities carried-out.
- Maintain the record of day to day activities and involvement of students and staff in the UBA activities.
- > Give wide publicity for the work done in UBA villages.
- > To submit the villages wise monthly report of all the activities carried out in UBA villages
- ➤ Prepare the Audit Utilization Certificate and submit to DEE through Associate Dean by 15th April.

Note: In case of more than one villages, college coordinator for UBA will have to coordinate with each of the village level UBA Co-coordinator for all above activities and submit the village wise reports. All four UBA Co-coordinators will have to work in group along with the UBA Coordinator to ensure the effective implementation of activities.
