			In exercise of the powers conferred under clause viii-a of sub-section 2 of Section 30 read with sub-section (3) of Section 35 of the Maharashtra Animal & Fishery Sciences University Act, 1998 (Principal Act), the Academic Council hereby makes the following regulation and alter the same having been approved by the Executive Council under clause (xvi to xix) of Section 27 of the Maharashtra Animal & Fishery Sciences University (Amendment) Act, 2023.
			<u>REGULATION NO. 37 /2023</u> [Amended as per Hon'ble Executive Council Res. No. 32(1)/2024]
1.0			Short Title and Commencement:
		1.1	These regulations shall be called "The Maharashtra Animal & Fishery Sciences University, Nagpur: Regulations for affiliation of Private Institutions offering degree course in Veterinary & Animal Sciences / Dairy Technology / Fishery Sciences.
		1.2	These shall extend to all private institutions who intend to affiliate or are affiliated (annual provisional or permanent, as the case may be) with Maharashtra Animal & Fishery Sciences University offering degree course in Veterinary & Animal Sciences / Dairy Technology / Fishery Sciences located anywhere within the whole State of Maharashtra.
		1.3	These Regulations shall be deemed to have come into force from the date of notification.
2.0			Definitions:
	2.1	a)	"Act" means the Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023 (Maharashtra Act No. XL of 2023).
		b)	"Academic Council" means the Academic Council of the University
		c)	"Academic Regulations" means the Maharashtra Animal & Fishery Sciences University Academic Regulations for award of Bachelor of Veterinary Science and Animal Husbandry (B. V. Sc. & A. H.) Degree Course / Bachelor of Technology (Dairy Technology) [B. Tech. (D. T.)] Degree Course / Bachelor of Fisheries Science (B. F. Sc.) Degree Course in vogue, as the case may be.
		d)	"Affiliated College" means a college which has been granted affiliation by the University. [The affiliation (annual provisional or permanent, as the case may be) with the University with respect to specific academic programmes]
		e)	"College/Institution" means any College or Institution affiliated



		to the University providing courses of study or training for admission to the examinations for Degree in Veterinary & Animal Sciences / Dairy Technology / Fishery Science of the University
	f)	"Director of Instructions" means the Director of Instructions of the Maharashtra Animal and Fishery Sciences University, Nagpur
	g)	"Executive Council" means the Executive Council of the University
	h)	"Faculty" means the faculty or faculties (Veterinary & Animal Sciences, Dairy Technology & Fisheries) constituted under section 31 of Maharashtra Animal and Fishery Sciences University Act 1998
	i)	"Government" means the State Government of Maharashtra
	j)	"Principal or Associate Dean" means Head of an Affiliated College or Institution
	k)	"Registrar" means the Registrar of the Maharashtra Animal and Fishery Sciences University, Nagpur
	l)	"Statutes" means the Maharashtra Animal and Fishery Sciences University Statutes 2002.
	m)	"Student" means a person who is admitted and enrolled in an Affiliated College or Institution of the University for receiving instruction or for qualifying himself for any degree conferred by the University.

	p)	"Vice-Chancellor" means the Vice-Chancellor of the Maharashtra Animal and Fishery Sciences University, Nagpur
	q)	"Principal Act" means Maharashtra Animal and Fishery Sciences University Act 1998 (Maharashtra Act No. XVII of 1998).
		Words and expressions used in the Act, Statutes and Regulations and not defined in these Regulations shall have the meaning assigned to it in the Act, Statutes or Regulations as the case may be.
3.0		Introduction:
	3.1	As provided under the sub-section (1) of the Section 35 A of Chapter VI of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023 (Maharashtra Act No. XL of 2023), under powers and functions of the University, it has been prescribed to affiliate colleges /institutions. Therefore, in order to streamline the process of affiliation as well as to provide strict and appropriate guidelines so as to maintain standards of education, these rules are being promulgated.
	3.2	Before approaching the University for provisional affiliation to Private Institutions offering degree in Veterinary / Dairy Technology / Fishery Sciences in the State of Maharashtra, the Society/Trust should carefully read the MAFSU Regulations for



		affiliation to Private Institutions offering degree in Veterinary / Dairy Technology / Fishery Sciences, VCI – MSVE Regulations, VCI (Procedure for recognition and de-recognition of Veterinary Colleges and Veterinary Qualifications) Rules, ICAR – Deans Report, ICAR – Minimum Requirements for Establishment of New College in Agriculture and Allied Disciplines and prospectus of the University provided for Degree in Veterinary / Dairy Technology / Fishery Science, as fulfilling the norms, as required in regulations, before the provisional affiliation and thereafter, shall be the sole responsibility of the Applicant Body.
	3.3	It is advised that before approaching the University for Annual Provisional Affiliation, the Applicant Body should have duly appointed a professional as a Principal / Associate Dean of the proposed College/Institution so that interactions on technical matters can be done with the Principal / Associate Dean for better understanding of technical matters.
	3.4	The University shall not be responsible for any kind of delay in provisional affiliation.
	3.5	The University may be providing Annual Provisional Affiliation to a College/Institution till it does not fulfill the requirements of Permanent Affiliation as mentioned in subsequent sections.
	3.6	Any College/Institution on Annual Provisional Affiliation shall be authorized to mention the status in the form of “With Annual Provisional Affiliation of MAFSU” on their signboards, letterheads, properties and other such documents.
	3.7	Till a College/Institute is permanently affiliated to the university as provided in these rules, the College/Institute shall not be authorized to declare its status anywhere as “Affiliated to MAFSU”. This is being prescribed in public interest and correct status depiction to the students.
	3.8	These rules are complimentary to the provisions in vogue or made in future by regulatory bodies like VCI, ICAR, Academic Council, Executive Council etc. In case, the central statutory bodies amends/modifies the minimum standards of education or any other existing provisions such amendments/modification shall be considered by the University through its Academic Council & Hon’ble Executive Council.
4.0		General Rules:
	4.1	It shall be mandatory for the institutes to abide by these Rules. Existing Annual Provisionally Affiliated Colleges/Institute(s) shall fit in these rules automatically, depending upon the stage in which they are currently running. They will have to switchover to these provisions immediately.
	4.2	Once, any institute is given Annual Provisional Affiliation, it shall be mandatory for that College / Institute to implement the directions/advice of the University, failing which, such Institute/College shall be inviting penalty, which may be financial, disallowing future admissions and/or withdrawal of affiliation.



4.3	It shall be the sole responsibility of the Applicant Body/Affiliated College to satisfy the requirements of the programme. The University shall not be responsible for any legal and financial liabilities arising out of the matters connected with the Applicant Body/Affiliated College/Institutions. The University shall also be not liable for any sort of (full or part) compensation regarding any matter pertaining to any party including students and or staff etc.
4.4	Annual Provisional Affiliation shall be for the academic purposes only. The Applicant body/College shall be bound to follow all directives of the Government/Department of Animal Husbandry/University etc.
4.5	The applicant body shall apply in the 'Prescribed application form' (Annexure I) having an enclosed self-declaration (Annexure II) on a Non-Judicial Stamp paper of Rs. 1,000/- (Rupees One thousand only) regarding facilities developed by the Applicant Body as per prescribed norms as mentioned in clause no. 4.17, 4.18 & 4.22 below for the first year and preparedness for the second year and growth plan.
4.6	If at any time during the continuation of Annual Provisional Affiliation, the Government/University raises any objection regarding adequacy of facilities, it shall be mandatory on the part of the College/Institute to fulfil the same in the prescribed time bound manner.
4.7	The University will grant affiliation to only one College/Institute for the respective degree course i.e. B. V. Sc. & A.H., B. Tech. (D.T.) & B. F. Sc. each per revenue division of the State. In case of receipt of more than one eligible proposal for affiliation of college for a particular degree programme from a revenue division, in such cases, the prescribed score sheet (MAFSU Regulations Annexure VI, VII & VIII as the case may be) shall be used for deciding the merit. However, the State Govt. may after considering the human resource requirement of the State grant more than one College/Institute for the respective degree course i.e. B. V. Sc. & A.H., B. Tech. (D.T.) & B. F. Sc. per revenue division..
4.8	Any punitive/suggestive/advisory action by the Government / University shall be binding to the College/Institute.
4.9	The University may appoint such number of Visitors or Inspectors, as it may deem requisite, to inspect any Annual Provisionally Affiliated College/Institute or to attend any examination or any other affair as the University deems fit. The visitors shall not interfere with the conduct of any training or examination, but shall report to the Vice- Chancellor on the adequacy of the standards including staff, equipment, accommodation, training and other facilities as prescribed. The report of the Visitor(s) shall be treated as confidential unless in any particular case the Vice-Chancellor otherwise directs.
4.10	The University shall be empowered to institute an inquiry into the



		affairs related to academics/admissions/any other matter, of the College/Institute, for which it shall be mandatory to provide required information and cooperate.														
4.11		No suit, prosecution or other legal proceedings shall be entertained against the State Govt., University or any officer or employee or any other person authorized by the State Govt. / the University for anything which is done or intended to be done in good faith under these guidelines to the notification issued their under.														
4.12		The applicant body/college shall be bound to respond to the provisions of RTI Act -2005 and operate in a transparent way with respect to all affairs of the college.														
4.13		The college/institute shall be required to ensure the attendance of the teaching, non-teaching staff and the students.														
4.14		<p>A committee consisting of the following will be constituted by this University for receiving and enquire into the grievance of the students or teachers and other staff of the said college/institute or the general public.</p> <table border="0"> <tr> <td>a. 4.15		Teacher, to be recruited before inspection of the college / institute by MAFSU, should have essential qualifications prescribed by VCI / ICAR and MAFSU. The college / institute will undertake recruitment of the faculty members through the Selection Committee, which should include Vice-Chancellor's nominee and Dean, Faculty as members. The selection criteria should be as per the MAFSU Statutes 171, 172 and 174. The model qualifications shall be mandatory for the selection of faculty members. The College shall appoint adequate non-teaching staff for the administrative wing and the laboratories.														
4.16		The society/trust of the said college / institute will be required to provide the bio-data of the faculty recruited along with their photograph and original academic certificates. If, any faculty member resigns or joins, the information must be furnished immediately.														
4.17		The admission of respective degree course [B.V.Sc. & A.H., B.Tech. (D.T.) & B. F. Sc.] (university plus management quota) will be as per the minimum standards of VCI / ICAR (as applicable) out of which fifty per cent of the seats will be filled up by the University and shall follow the reservation pattern as per the State Government guidelines. The rest fifty per cent seats (Management Quota) shall														



		also be filled up by the University from the merit list prepared by MAFSU through prescribed admission test. The fee structure for the university seats and management quota shall be decided by the committee constituted under Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 as mentioned in clause 4.19 of this regulation.
4.18		The college shall possess the minimum land and equipments/instruments required for establishing the College of Veterinary Sciences as per VCI norms, College of Dairy Technology & College of Fishery Science as per ICAR norms.
4.19		The fee for both regular quota and management quota shall be decided by the committee constituted under Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015.
4.20		The MAFSU Academic Regulations of respective degree course <i>in vogue</i> shall be applicable to the colleges for the award of respective degree course.
4.21		The admission for all the seats shall be made on the basis of the inter-se merit of the candidates in the prescribed entrance test (NEET/MHTCET etc.), as applicable. The counselling for admission to all the seats will be done by the University. Only those students who have cleared the prescribed Entrance Test as suggested by the University shall be eligible for both type of seats. The complete fee with all funds will be deposited with the University and the society/ trust/college/institute will not be allowed to charge any money directly. The University later will transfer the money into the accounts of the college as per Annexure IV (7) of this regulations.
4.22		Prior to admission, the college must set up various departments including dissection hall, well-equipped laboratories, Teaching Veterinary Clinical Complex, agricultural farm, animal house/ farm and other essential facilities required for teaching in the subsequent semesters, at the earliest based on minimum standards, and other teaching and training facilities like library, computer laboratory, students counselling facilities and museum, etc. required for the first year B.V.Sc. & A.H., B. Tech. (D.T.) & B. F. Sc. course. The management should submit detailed project report, plans and estimates related documents along with the application for provisional affiliation. In any case, the essential requirements for the courses to be taught in 3rd and 4th semester with regards to infrastructure, building, animal farm, staff, laboratory, equipment etc. as per VCI & ICAR norms must be in place before the end of first six months of the academic session.
4.23		The college should uphold the sanctity of examinations and shall abide by the rules and regulations of the University for Internal as well as External examinations and evaluation system.
4.24		The college shall develop, preserve and maintain a conducive academic atmosphere with zero tolerance to ragging and shall not allow, promote or encourage any activity adverse to it.
4.25		The college should also have a 'cell' to address the atrocities, if any, on women, SC/ST or minorities as per Government rules.



5.0		Annual Provisional Affiliation for New Colleges for First Year Admission:
	5.1	The prescribed application form (Annexure I) shall be made available at a charge of Rs. 5,000/- (Rupees Five Thousand only) as Application Form Charges (Annexure IV).
	5.2	Application for Provisional Affiliation shall be in the prescribed format along with Non- Refundable Processing Fee of Rs. 5.00 Lakhs (Rupees Five Lakhs only) (Annexure IV). This application shall be valid for, only forthcoming academic session. If the applicant fails to obtain affiliation of the University, it shall have to apply afresh for the next session, by obtaining fresh prescribed application form and depositing application fee along with filed application form. The last date for submission of application for affiliation in the office of the Registrar of the University will be 31st March of the preceding year of admission of first batch so that the University gets ample time to process, inspect and affiliate. The last date shall be 30th April with late fee of Rs.50,000/-. However the University shall complete the inspection & other process for affiliation by June 30th of preceding year of admission. The queries raised by the University with regard to the application shall have to be complied promptly by the applicant within the time specified or else the University shall not be responsible in processing the proposal in time.
	5.3	The processing fee is to be paid in the form of a bank draft drawn in favour of the 'Comptroller, MAFSU, Nagpur' payable at Nagpur along with essential documents and a self declaration regarding facilities developed by the applicant body as per the Veterinary Council of India (VCI) / Indian Council of Agricultural (ICAR) norms for the First year of B.V.Sc. & A.H. / B. Tech. (DT) & B.F.Sc. and growth plan for the second and subsequent years.
	5.4	Incomplete application shall be rejected and fee forfeited, however, applicant shall be free to file fresh application.
	5.5	When the first-year requirements are completely met, the management for the proposed college/institute will file the application for provisional affiliation. The applications received on or before the last date of submission shall be scrutinized by a Scrutiny Committee constituted by the University. The Scrutiny Committee shall submit a report of deficient documents and other information to the University. The applicants shall be communicated to make a presentation of the facilities to the University authorities, submit a video and power point presentation of the available facilities. If the facilities are seemingly inadequate, the Applicant Body shall be communicated so during the presentation and in writing also. In such a case, the Applicant Body shall develop adequate facilities and again make a presentation, with fresh video and power point presentation to the University authorities.
	5.6	The University may decide such authorities, who shall be present at the time of presentation for recommending adequacy/otherwise



		to the university. The presentation shall be open to all faculty members of the university.
	5.7	Consequent to presentation and viewing the Video, if the University authorities are satisfied that the facilities developed by the applicant body are worth inspecting, the University shall send a Inspection / Affiliation committee for inspection constituted as per Section 35A (3) (a) of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023.
	5.8	The Applicant Body shall have to deposit Non-Refundable Inspection fee of Rs. 1.0 Lakh (Rupees One Lakh only) (Annexure IV) in the form of a bank draft drawn in favour of the 'Comptroller, MAFSU, Nagpur' payable at Nagpur to the University.
	5.9	The Inspection / Affiliation Committee (as constituted by the university) shall visit the College/Institute after satisfactory presentation. The College /Institute shall extend all facilities and cooperation to the Inspection / Affiliation Committee. The Committee shall inspect the facilities in the light of the VCI/ICAR norms as the case may be and MAFSU Regulations and give scores to the institute in the prescribed score sheet (Annexure VI, VII & VIII as the case may be). The Committee shall submit the report to the Registrar for placing before the Academic Council meeting as per Section 35A (3) (c) of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023.
	5.10	If the Inspection / Affiliation Committee notices deficiencies in the infrastructure or the manpower, in such cases, the Committee shall immediately communicate the same within 07 days to the applicant with directives to comply the deficiencies for further processing of proposal with a copy to the Registrar. The proposals that qualifies all the requirements shall be placed before the Academic Council as per the clause 5.9 above. If the Academic Council approves, the Inspection / Affiliation Committee report along with Academic Council's recommendation shall be placed in the meeting of Executive Council. Otherwise it will be returned back to the Applicant Body of the proposed College/Institute for improving the facilities for re-inspection on a future date.
	5.11	On the recommendation of the Inspection / Affiliation Committee and the Academic Council, the Executive Council may forward the proposal of affiliation of the proposed college of the Applicant Body to the State Government as per Section 35A (4) (i) of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023.
	5.12	The State Government may, grant or refuse the permission, as it may deem fit, after verifying the proposal sent by the Executive Council as per Section 35A (4) (ii) of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023. The State Government will issue 'No Objection Certificate' and 'Essentiality



		Certificate' to the applicant body offering degree in Veterinary / Dairy Technology / Fishery Sciences, if State Government grants permission.
	5.13	It shall be the responsibility of the affiliated college or institution who has been granted permission by the State Government to get the recognition from the Veterinary Council of India or Indian Council of Agricultural Research, as the case may be. Proposals for recognition shall be forwarded through the University to Veterinary Council of India or Indian Council of Agricultural Research, as the case may be. The University shall issue the letter of consent of affiliation to the applicant body. The University shall provide report of the Inspection / Affiliation Committee regarding the availability of facilities at the proposed affiliated college. It shall be the responsibility of the affiliated college to maintain the recognition of the Veterinary Council of India or Indian Council of Agricultural Research, as the case may be, from time to time as per Section 35A (4) (iii) of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023. The University shall only be acting as a facilitator, without any legal, financial or consequential liabilities arising out of the matters connected with affiliation.

	5.16	The provisionally affiliated college shall create reserve funds by investing fixed deposit of Rs.20.0 Lakh (Rupees Twenty Lakh only) within one year of start of college positively.
6.0		Admission of Students and subsequent Annual Provisional Affiliation
	6.1	The affiliated College/ Institute shall not be able to admit students for the session without subsequent affiliation by the University for continuation of admitted students.
	6.2	The college must obtain approval of the VCI prior to admission of

	6.3	Before the end of first six months of the academic session, the second-year requirements should be completely met. 7.3		The Permanent affiliated colleges shall have to deposit annual administrative expenses @ 5% of the total fee charged from all the enrolled students in the beginning of session or Rs. 2 Lakh whichever is higher (Annexure IV). This fee should be submitted within one month of last counselling as per prospectus.
8.0		Withdrawal of Affiliation
8.1		The Permanent Affiliation / Annual Provisional Affiliation granted to a College/Institute may be withdrawn, in whole or in part or modified by the University as per the procedure given in the Section 37A of Maharashtra Animal and Fishery Sciences University (Amendment) Act 2023.
8.2		The Permanent Affiliation / Annual Provisional Affiliation granted to a College/Institute may be withdrawn or modified if the College/Institute fails to comply with any of the provisions/direction of affiliation specified by the University or Government at any stage of affiliation.
8.3		In case of finding deficiency, the University may also resort to reduction of intake capacity, to the level deemed fit, for one or more academic session.
8.4		The Inspectors/Visitors/any other person authorized by the University, while submitting their reports/communication to the University, points out any deficiency(ies) violation of affiliation provision/non-compliance of directives of regulatory body/affiliating University, the University may impose financial penalty on the Institute/College. In such cases the University would advise the concerned Institute/College to rectify the deficiency/violation of provisions/compliance of directives in a stipulated time along with the payment of penalty. If institute / College fulfils the above requirements in the stipulated time, University may depute the inspector/visitor/ any other person again, to verify the remedial measures, taken by the College/Institute.
8.5		The privileges conferred on a College/Institute by affiliation may

		be withdrawn in part or in full, suspended or modified, if the College/Institute on due enquiry, is found to have failed to comply with any of the provisions of the Act / Statutes, the Ordinances, the Rules and Regulations or any other direction or instruction of the University, or failed to observe any of the conditions of affiliation, or has conducted itself in a manner prejudicial to the academic and administrative standards and interests of the University.
	8.6	When an affiliated College/Institute ceases to function or is shifted to a different location or is transferred to a different Society, Trust, individual or a group of individuals without the prior approval of the University, the affiliation granted to the college/Institute shall lapse automatically. Thus under such condition shifting or transfer, as the case may be, it shall be treated as a new College/Institute for the purposes of future affiliation.
	8.7	The University on its own, on the basis of any complaint or any other information or report from any other source, can cause an enquiry in respect of a College/Institute, and after giving the College/Institute a reasonable opportunity of being heard, may pass an order prohibiting such College/Institute from presenting any student then undergoing such specified course/programme of study therein to the University for the award of the concerned Degree in this case.
	8.8	In cases where the Institute/College does not fulfill the requirements or remedial measures taken are not adequate, the University may submit the report of such Institute/College to the Academic Council, recommending withdrawal of affiliation of the Institute/College as per clause 8.1 above.
	8.9	The College/Institute shall be deemed to be de-affiliated consequent to withdrawal of affiliation by the State Government.
	9.0	Saving :
		The University reserves the right to amend the regulations/rules/procedures/fee(s), related to affiliation of College(s) Institute(s) and submission of form for fresh affiliation in future without prior information to the College(s)/Institution(s). Similarly, in the event of any difficulty arising at any time in the implementation of the provisions of these Regulations or in interpretation thereof. The decision of the Government shall be final and binding on all the concerned.
