**Nomination of Ombudsperson as per the UGC
(Redressal of Grievances of Students) Regulations,
2023 for Maharashtra Animal and Fishery
Sciences University, Nagpur.**

ORDER


In persuasion of the provisions of University Grants Commission (Redressal of Grievances of Students) Regulations, 2023, clause no. 6 and MAFSU Act 1998, Section 17 (9), the Hon'ble Vice-Chancellor, Maharashtra Animal & Fishery Sciences University, Nagpur is pleased to nominate Dr. S. N. Rokde, Retd. Project Coordinator and Principal Scientist & Head, Krishi Vigyan Kendra, ICAR - Central Institute of Cotton Research, Nagpur as Ombudsperson for Maharashtra Animal and Fishery Sciences University, Nagpur and its constituent colleges/institute as per the below terms and conditions:

1. The Ombudsperson is nominated for a period of three years or until he attains the age of 70 years, whichever earlier from the date of assuming office.
2. For conducting the hearings, the Ombudsperson shall be paid a sitting fees of Rs. 2500/- (Rs. Two Thousand and Five Hundred Only) per hearing and conveyance allowance.
3. The Ombudsperson shall hear appeals from an aggrieved student, only after the student has availed all other remedies provided under University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.
4. While issues of malpractices in the conduct of examination or in the process of evaluation may be referred to the Ombudsperson, no appeal or application for revaluation or re-totalling of answer sheets from an examination, shall be entertained by the Ombudsperson unless specific irregularity materially affecting the outcome or specific instance of discrimination is indicated.
5. The Ombudsperson may avail assistance of any person, as amicus curiae, for hearing complaints of alleged discrimination.
6. The Ombudsperson shall make all efforts to resolve the grievances within period of 30 days of receiving the appeal from the aggrieved student (s).
7. The Ombudsperson shall follow the procedure for redressal of grievances as per the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023.

8. In case, the Ombudsperson intends to resign, he shall have to tender one month notice to the University.
9. The University reserves the right to remove the Ombudsperson from office, on charges of proven misconduct or misbehavior.

The above order is issued in the interest of the university.
