At the outset, Dr. Bhikane, Director of Extension Education (DEE) & Member Secretary, ECEC, MAFSU welcomed Hon'ble Chairman and members for the 15th meeting of the Extension & Continuing Education Council (ECEC) of the University.

Dr. Niteen Patil, Hon'ble Vice-Chancellor & Chairman, ECEC also welcomed the members of the Extension & Continuing Education Council (ECEC) attending the 15th meeting of ECEC and briefed the house about significant achievements of extension activities of University during previous year. The regular agenda of the meeting was then taken up for discussion with the permission of Hon'ble Chairman.

Dr. Bhikane, DEE & Member Secretary informed the house that the minutes of 14th meeting of Hon'ble Extension & Continuing Education Council held on 08th March 2022 were circulated to all the members and no suggestions and remarks were received to the university from any member. He further requested the members to present their observations, if any with regards to the minutes of last meeting. Dr. Bhikane, DEE & Member Secretary placed the action taken report of the decisions of 14th meeting of Hon'ble Extension & Continuing Education Council held on 08th March 2022 before the house.

After thorough deliberations the house expressed satisfaction over the action taken report and following resolution was passed.

Subject No. 3/2024

Regarding the review of Extension Activities conducted by the constituent colleges / institute during the calendar year 2022 & 2023.

Before taking up the review of extension activities of constituent colleges, Dr. A. U. Bhikane, Director of Extension Education briefed the significant achievements with respect to strengthening the extension activities of the University and presented the significant initiatives taken by the Directorate of Extension Education. He appraised the house about various projects implemented through extension wing such as Micro Training Centres (MTC) sponsored by NDDB, Anand; Pashusakhis training funded by MAVIM, Mumbai, Maharashtra; Awareness programme for SC beneficiaries under ICAR Schedule Caste Sub plan by National Meat Research Institute, MAITRI training programmes sponsored by MLDB under RGM; SMART training programmes sponsored by Dept. of Animal Husbandry Govt. of Maharashtra; exemplary work rendered during LSD outbreak and its control; Fishery Expo; MoU with major institutions and organizations of repute such as Pani Foundation etc.; felicitation of progressive farmers on the occasion of Kisan Diwas; Significant contribution in Vidarbha- Marathwada Dairy Development Project (VMDDP), "Dudh Pya Dirghayushi Vha" campaign through participation of number of schools and its media coverage etc., MAFSU Museum was inaugurated on University Foundation Day; various advisories issued by MAFSU through M-Kisan portal; participation in State level Maha Pashudhan Expo held at Shirdi and National level Agro-Vision at Nagpur; trainings imparted to LDOs under Rashtriya Gokul mission; activities undertaken at adopted villages under Unnat Bharat Abhiyan; publications of University (MAFSU calendar, Newsletter, Annual Report, 26 leaflets and MAFSU Diary). He further proposed that, on the eve of Silver Jubilee year of MAFSU, Nagpur, a special campaign

highlighting importance of milk will be launched by the MAFSU, Nagpur from 01st June, 2024 ie. "World Milk Day".

Dr. Bhikane, DEE & Member Secretary, further provided an update on the progress of Krishi Vigyan Kendras (KVKs) under MAFSU. He reported that administrative building of KVK Nagpur is completed and administrative building of KVK Sangli and Farmers Hostel of KVK Thane is on the verge of completion, and the construction of administrative building of KVK Thane and Farmers Hostels at KVK Nagpur and KVK Sangli is ongoing and shall be completed in next 6-8 months. He acknowledged the valuable assistance provided by the ICAR-Agricultural Technology Application Research Institutes (ATARI), Pune, in this endeavor. He informed that recruitment processes are currently held up at MAFSU, Nagpur, due to administrative reasons.

DEE also informed the house about new initiatives launched by MAFSU, Nagpur. These include the implementation of Digital farm schools "Sheti Shalas" in collaboration with Panni Foundation, aimed at providing technical guidance to farmers in dairy farming, poultry, and fisheries. Additionally, initiatives such as the campaign to achieve zero human dogmediated rabies deaths by 2030, training of trainers for climate resilient technologies, involvement of Lower Education Schools of MAFSU in extension activities, Nagpur, and awareness campaigns on fodder production have been initiated. Furthermore, MAFSU staff members have been encouraged to undertake extension work focusing on region specific farmers needs. DEE assured that the constituent colleges under MAFSU, Nagpur, along with their staff, would continue their extension work in the livestock, poultry, dairy and fisheries sectors with the same enthusiasm. He expressed gratitude for the support and guidance provided by the Honorable Extension & Continuing Education Council members of MAFSU, Nagpur.

Following Dr. Bhikane's comprehensive presentation on the University's extension activities, the esteemed members of the Extension & Continuing Education Council shared their valuable insights. Dr. S. K. Roy, Director of ATARI Pune, highlighted the pivotal role of extension work in doubling farmers' incomes in the animal husbandry and horticulture sectors over the past decade. He informed about the significant government investment of Rs. 350 crores in the 'Livestock Development project' through ATARI Pune, highlighting its importance for sectoral growth. Dr. Roy stressed the critical need for skill development among farmers, emphasizing the essential role of KVKs and their Subject Matter Specialists in this endeavor. He further accentuated the urgency of prioritizing recruitment in KVKs for all the sanctioned posts.

Dr. Kiran Kokate, Former DDG, Agriculture Extension, ICAR, New Delhi highlighted that the leadership of MAFSU who is giving importance to the Extension activities is noteworthy. He appreciated the initiatives and efforts of the MAFSU, its constituent colleges and the staff involved in the extension activities, development of MAFSU Museum by the

University, complimented on the publication of MAFSU diary although suggested some improvements in it such as insertion of text on business models, forward and backward linkages, project and capacity development programme of the University for benefit of the farmers. He further suggested that the 3 'C's – Conflicting situations, COVID-19 situation and Climate Change must be given due attention while planning extension programmes, 'One Health' approach to combat zoonotic diseases, recommending collaborations with ICAR and other institutes to undertake district-wise pilot projects on model fodder development in partnership with NGOs and institutions. He suggested promoting the cultivation of leguminous plants and advocating for a scientific approach to technology dissemination in the veterinary, animal husbandry, dairying, and fisheries sectors.

Additionally, Dr. Kokate proposed organizing livestock exhibitions and festivals before the onset of the monsoon, patenting innovative ideas, developing business models for farmers in animal husbandry, dairying, poultry, and fisheries, and enhancing coordination between the academic, research, and extension wings of the university. He stressed the importance of showcasing the outputs and impacts of extension activities to both the public and the government.

Hon'ble Vice Chancellor & Chairman, ECEC, Dr. Niteen Patil opined to review activities of last 25 years and the future extension activities would be planned accordingly taking into consideration the suggestions given by the Hon'ble ECEC members. He further mentioned that there is region wise disparity in milk production and appropriate steps would be taken to fill the gaps in technology dissemination, similarly efforts would be taken to enhance productivity of the low milking animals, research would be extended to the large farming areas and in the regional revenue divisions through Research Farms of the constituent colleges in these areas.

After the initial discussion, the extension material of the University was published at the hands of the Hon'ble Vice Chancellor and Hon'ble members of ECEC, MAFSU, Nagpur. Publications of the University during 2024:

Hon'ble Vice Chancellor felicitated University Officers and faculty members for their exemplary contribution in the development of the MAFSU Museum Dr. S. V. Upadhye, Director (Instructions) & Dean (Vet.), MAFSU; Dr. S. W. Bonde, Dean (Fisheries), MAFSU; Dr. A. P. Somkuwar, Associate Dean, NVC, Nagpur; Dr. P. G. Wasnik, Dean (DT), MAFSU; Udgir; Dr. M. R. Patil, Associate Dean, DTC, Udgir and Dr. Sariput Landge, Assistant Professor, NVC, Nagpur and the Technical Officer, DEE, MAFSU, Nagpur and Dr. N. Z.

Gaikwad, Associate Dean, COVAS was also felicitated for his contribution in preparation of MAFSU Diary 2024.

Thereafter, Dr. Bhikane, DEE requested the Associate Deans of the constituent colleges/institute of MAFSU to present the report of extension activities carried out during the Calendar Year 2022 (January – December 2022) and Calendar Year 2023 (January – December 2023).

Mumbai Veterinary College, Mumbai

Upon presentation of MVC, Mumbai by Dr. S. D. Ingole, I/c Associate Dean, Hon'ble Chairman expressed concern about the absence of programs conducted through ATMA funded projects at MVC, Mumbai and highlighted the critical issue of limited awareness about modern technologies, particularly in remote rural areas, such as innovative feeding practices. He stressed the importance of implementing training programs in these regions, ensuring that vital techniques such as enriching the quality of roughages are made accessible to all. This approach aims to bridge the gap between technological advancements and the rural populace, facilitating inclusive development and sustainable practices.

Dr. Satish Raju, proposed reaching out to the State government and industry for collaboration, emphasizing the potential to leverage available funding for the benefit of farmers. This collaborative approach can enhance the utilization of funds allocated to projects, ultimately leading to tangible improvements in agricultural practices.

Dr. N. Sridhar suggested enhancing the visibility of MAFSU through television and radio programs, fostering partnerships with industry stakeholders, and promoting the dissemination of modern technologies.

Dr. Upadhye brought to attention a concerning issue regarding the college's utilization of grants allocated under the Tribal Sub Plan (TSP) project. He emphasized the need for closer examination and proactive measures to ensure optimal utilization of the TSP grants, thereby maximizing their impact on the targeted tribal communities and fulfilling the objectives of the project.

Dr. Kokate suggested to utilize the funds for various demonstrations at the Krishi Vigyan Kendra (KVK), emphasizing the importance of developing on-site demonstration units. This approach allows for practical, hands-on learning experiences for farmers, enhancing the effectiveness of extension activities. He further recommended organizing regular innovative programs throughout the year, such as radio programs to increase the visibility of the university's communication strategy in Maharashtra. This would involve dedicating a regular slot for radio programs to showcase various success stories, enhancing outreach and engagement with the community. He further stressed to formulate quarterly activity plans through SAC meetings and to collaborate with other ICAR institutes to implement these activities efficiently.

DEE emphasized the importance of focusing on localized activities in UBA adopted villages once funds are disbursed, urging for a targeted approach that addresses specific community needs. He mentioned that the University has MoU with ADRISE, Mumbai and the college can think of developing online training programmes in collaboration with ADRISE.

Nagpur Veterinary College, Nagpur

Upon presentation of NVC, Nagpur by Dr. A. P. Somkuwar, Associate Dean, Hon'ble Vice Chancellor emphasized the importance of exploring avenues to raise revenue through the implementation of paid training programs. Dr. Bhikane, DEE advocated for the expansion of Unnat Bharat Abhiyan activities by the college. He highlighted the significance of community engagement and development initiatives as a means to bridge the gap between academia and rural development needs. He also emphasized on documentation of success stories established by the College. Dr. Kokate urged to establish clear connections between the inputs and the tangible outputs achieved particularly in terms of employment opportunities generated through extension efforts. He proposed that profits, after deducting expenses, should be included in revenue generation, ensuring a comprehensive assessment of financial outcomes. He emphasized the importance of creating jobs, particularly for the youth, within the agricultural sector. He opined to incorporate programs such as ARYA and MAYA into the planning of extension activities.

College of Veterinary and Animal Sciences, Parbhani

Upon presentation of COVAS, Parbhani by Dr. B. W. Narladkar, Associate Dean, Dr. Bhikane, DEE proposed increasing the frequency and scope of UBA (Unnat Bharat Abhiyan) programs conducted by the college. Dr. Kokate proposed using the term "operational villages" instead of "adopted villages" for clarity. Additionally, Dr. Kokate recommended creating 1-2-minutes short YouTube video and suggested producing shorter, advisory videos such as "Maza Gotha Swaccha Gotha" to amplify the message and to disseminate information effectively to reach a wider audience. Hon'ble Vice Chancellor urged for the documentation of the number of entrepreneurs nurtured and developed through the college's initiatives. Dr. Satish Raju emphasized the need to intensify efforts in poultry and goat farming, suggesting collaboration with the State Department to enhance these endeavours.

College of Veterinary and Animal Sciences, Udgir

Upon presentation of COVAS, Udgir by Dr. N. Z. Gaikwad, Associate Dean, Hon'ble Vice Chancellor & Chairman, ECEC suggested for quarterly assessments of extension activities proposed to ensure proper execution. He proposed establishing uniform dates for celebrating international days across all colleges and advocated for awareness campaigns through published circulars on these occasion. Additionally, he suggested to invite speakers, have

Morning rallies "Prabhat feri", organize campaign on the occasion of international/ National day, to maintain repository of radio talks, explore more Akashwani, Doordarshan programmes, increase blogs and Podcast by the staff, follow working style and the activities of other popular KVKs, arrange various competitions for livestock farmers, etc. Upon this DEE, Dr. Bhikane assured to bring such uniformity at each constituent college of university.

Shri. Metkar recommended to promote medium-sized poultry and goat businesses. Dr. Rajesh Jaipurkar suggested conducting training sessions on silage making for farmers from Melghat for addressing the fodder scarcity issue. By equipping them with silage-making technology, the need for migration during summers could potentially be eliminated, ensuring agricultural sustainability and livelihood stability in the region. Dr. Satish Raju suggested silage as a solution to address the fodder scarcity issue for dairy farmers "Gavali people" in Melghat.

Hon'ble Vice Chancellor instructed Associate Dean, PGIVAS Akola, to enhance extension activities in Melghat, focusing on forward/backward linkages in the agricultural supply chain. He further directed that each college must identify the dominant production system in its district. The respective college can then enhance its extension efforts, focusing specifically on that production system. He urged the identification of relevant NGOs to support rural employment initiatives and emphasized collaboration with animal husbandry experts to address issues in Melghat.

Kranti Sinh Nana Patil College of Veterinary Sciences, Shirwal

Upon presentation of KNPCVS, Shirwal by Dr. A. H. Ulemale, Representative of Associate Dean, Hon'ble Vice Chancellor & Chairman, ECEC suggested to compile success stories aligned with disseminated technology, organizing theme-based Akashwani programs at every three months, enhancing revenue receipts, developing farmer-friendly mobile applications, and ensuring the availability of all college publications and research papers on the college website for easy access.

Postgraduate Institute of veterinary and Animal Sciences, Akola

Upon presentation of PGIVAS, Akola by Dr. C. H. Pawshe, Associate Dean, Hon'ble Vice Chancellor & Chairman, ECEC expressed concern over non-adoption of goat farming by the farmers in the region and suggested the need of discussion on goat breeding and rearing challenges. Dr. Mahesh Bondge highlighted the challenges associated with breeding and rearing of Berari and local goats, particularly focusing on concerns such as weight gain and inbreeding. He stressed the urgency of finding solutions to these issues and urged all stakeholders to collaborate in addressing the real-time challenges faced by goat farmers.

College of Dairy Technology, Warud/Udgir and college of Fishery Science, Nagpur/Udgir

Dr. P. G. Wasnik and Dr. M. R. Patil, Associate Dean, CDT, Warud and Udgir respectively presented the report of extension activities carried out during the last two years. Dr. S. W. Bonde and Dr. B. R. Kharatmol Associate Dean, College of Fishery Science, Nagpur and Udgir respectively presented the extension activities of the college.

Upon presentations by the respective Associate Deans in the faculty of Dairy Technology and Fisheries, Hon'ble Vice Chancellor & Chairman, ECEC proposed the implementation of activities conducted through ATMA projects. He emphasized the potential benefits of leveraging ATMA-funded initiatives to enhance agricultural practices, technological adoption, and rural development. He highlighted the importance of aligning these activities with the goals and objectives outlined within the ATMA framework, which focuses on promoting sustainable development, improving productivity, and empowering farmers through capacity building programs. His suggestion aimed to capitalize on external funding opportunities and collaborative partnerships to drive innovation, knowledge transfer, and overall positive change within the sector.

Hon'ble Vice Chancellor & Chairman, ECEC requested Hon'ble Members to offer their suggestions/remarks on the activities carried out by the constituent colleges/institute, WRTC and KVK's.

Hon'ble Member, Smt. Mahalle opined to increase in number of farmers training programme in the domains of Animal Husbandry, Poultry, Dairying, and Fisheries sectors in the Melghat area, emphasizing their crucial necessity.

Hon'ble Member, Dr. Bhondge suggested to issue of real-time "Press Releases" to update the public about the current situations and developments in the poultry sector. He commended the University's extension efforts and recommended that the institution should give wide publicity for the Minimum Support Price (MSP) rates for poultry products, including eggs and broiler birds. He also emphasized the importance of disseminating the outcomes of pilot studies and research projects to the grassroots level through extension programs.

Hon'ble Member, Shri. Metkar expressed the need of establishing a specialized laboratory on Feed analysis within the University, aimed at providing farmers with continuous guidance.

Hon'ble Member, Shri. Majid Khan mentioned that the Government schemes under NLM and RLM are only for large size dairy farmers and not for small and marginal farmers. He emphasized the need that University should find out solutions to enhance the productivity of cows, including DNA testing of male and female animals to predict their growth and milk production levels in advance. He also stressed to conduct more research and extension on the Khillar breed. Hon'ble Chairman appraised that KNPCVS, Shirwal has excellent research facilities and has been actively providing training and extension support to farmers regarding

the Khillar breed. He further informed that IVF technology could also prove beneficial in this endeavour.

Shri. Raju Ingale stated that the Pashu Sakhis trained at the MAFSU Centres need to get approval as qualified Extension Workers by the State Government. He suggested the creation of an animal database utilizing the services of Pashu Sakhis, along with dissemination of University technologies to the community through their assistance and network.

Dr. Thoke, requested to organize training program for farmers on fish culture in farm ponds in Nashik and Ahmednagar districts. He addressed the prevalent myth that fish farming in ponds is not beneficial, emphasizing the necessity for training in this domain. He suggested that MAFSU could utilize YCMOU infrastructure for assistance. Dr. Bonde, Dean of Fishery Science, clarified that fish culture in farm ponds is indeed feasible, and assured to extend facilities for the training program for farmers in Nashik and neighbouring districts.

Hon'ble Member, Dr. Roy suggested that that the University may plan for convergence programme, a good programme on Livestock Development to be conceived by the University. Additionally, he emphasized the urgent need to fill staff positions in the KVK, stating that funds are already allocated to the University for this purpose.

Hon'ble Member, Dr. Kokate praised the extension work of MAFSU carried out through its various establishments. He suggested the development of extension and training programs specifically tailored for Tribal Youth, with training sessions addressing industry-specific challenges in Poultry, Dairy, etc., along with proposed solutions by the University. He further suggested the introduction of integrated technologies with micro interventions aimed at mitigating farmer suicides. Stressing the importance of the livestock and fisheries sectors in the nation's journey towards a 5 trillion-dollar economy, he proposed that the University's extension work be centred around the 'Farmer First' concept. He also advocated for the promotion of 'Integrated Farming Systems' to ease the burden on farmers. Additionally, he suggested replicating successful methodologies from MAFSU Yashogatha in other areas of the state and modifying and publishing success stories accordingly. He urged for the optimization of the college and university websites to be farmer-friendly, akin to those of IARI, IVRI, and TANUVAS, etc.

Dr Kokate also appreciated the incredible work of WRTC, Gorewada and suggested exploring international collaborations and partnerships in animal care and treatment. Regarding Zoonoses, he recommended researchers from the University to explore insights from the 'MY COW App.' He further appreciated efforts like Fisheries Interest Groups and FFPO and highlighted that the similar efforts may be replicated in the livestock sector.

- 8. Output and Impact Assessment of extension activities like trainings, demonstrations, animal health camps should be carried out and Pre-training and post-training evaluations of every training should be carried out. (Action: All Associate Deans & Head KVKs)
- 9. The efforts should be made to improve the animal husbandry and dairying in the tribal areas like Melghat emphasizing the development of sustainable livelihood for the tribal communities (Action: Associate Dean, PGIVAS, Akola)
